
# **Objective of the Workshop**

At its sixty-sixth session in 2014, the International Law Commission (ILC) commenced work on drafting what may become a Convention on the Prevention and Punishment of Crimes against Humanity. The Special Rapporteur for the project, Professor Sean D. Murphy, submitted a first report in 2015 outlining the general scope of the project and proposing initial draft articles, which led to the adoption by the ILC of draft articles 1-4 with commentary. The Special Rapporteur submitted a second report in 2016, which led to the adoption by the ILC of draft articles 6-10 with commentary. The Special Rapporteur submitted a third report in 2017, which led to the adoption by the ILC of a draft preamble, draft articles 11-15 and a draft annex, all with commentary.

This completes the "first reading" (or first draft) of the ILC's work on this topic. The ILC is now accepting comments from governments and other interested actors before proceeding to the "second reading" (or final draft) in 2019.

The objective of this workshop is to provide an opportunity for interested individuals from across the Latin America and the Caribbean region to engage in a discussion with the Special Rapporteur on the work of the International Law Commission to date, both to learn about the initiative and to suggest improvements to the text of the Draft Articles.
