

Applying for a VISA for the Netherlands to attend ASP17

- To enter the Netherlands you will have to apply for a short stay Schengen visa.
(Do you need a VISA? Please find annexed –below- a list of countries whose nationals need a VISA to enter the Netherlands).
- You can apply for a visa starting from 3 months before the date of your travel; make sure to apply as soon as possible as **AN EMBASSY CAN TAKE UP TO 15 WORKING DAYS TO ISSUE A VISA.**
- The CICC Secretariat cannot contact directly any Embassy to speed up the process and timely application is therefore crucial.
- The visa applicant has to submit documents showing proof of
 - The purpose of the intended journey
 - Proof of accommodation and travel itinerary
 - Proof of sufficient means of subsistence for the intended stay in The Netherlands and for return to country of residence
 - Proof of social and economic ties with country of residence (family, job, etc.)
- The documents required may slightly vary from country to country. - Should you need a support letter for your application, please contact the Coalition's Secretariat at asp@coalitionfortheicc.org stating "ASP17 VISA" in the subject line.
Please provide the following information:
 - Complete Name/Surname
 - Name of the Organization you work for & your position
 - Nationality
 - Passport Number
 - Applying for visa in: Country? Embassy? (Eg. Embassy of the Kingdom of the Netherlands in Rome, Italy).
- Please inform the Coalition's Secretariat in any case when submitting a visa application. Please keep the Coalition's Secretariat informed on the status of your application (when you obtain an appointment and for which day, how the appointment goes).
